4.1. Description of first aid measures

Skin contact: Remove all contaminated clothes and footwear immediately unless stuck to skin.

Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide (CO2). Dry chemical powder. Alcohol resistant foam. Sand or earth. Do

NOT use water jet.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: In a fire, hazardous decompostition products such as smoke and Carbon Monoxide may
